Approval of the Minutes

Gillespie moved to accept the February 28, 2023 minutes. Seconded by Capogrossi.

Public Comment Period:

Susan Ainslie stated that she was the Board of Trustee Liaison.
Schleelein moved to close the Public Comment period. Seconded by McCauley.
Ayes: Baker, Capogrossi, Gillespie, McCauley and Schleelein.

Baker read the following agenda item:

Review of New Landscaping Plan for Special Permit #2020-4366

There has been a change in the approved landscaping plan for 20 Blackchin Blvd. As Per the conditions listed for the Special Permit #2020-4366 resolution, the Planning Board must approve the final landscaping plan and the Village Code Officer and The Village Engineer must sign off after inspection.

42 Scott stated that he and Brent Cross had spoken about the proposed changes in landscaping and
43 how those changes would affect the stormwater on that site. Cross told Scott that there would be
44 no significant effect on stormwater.

45

46 Baker described which site plan was which that was provided to the Planning Board.

47

48 Ward, who was the Eggert's representative, gave a brief history of the project which started about
49 4 years ago. Ward stated that Dan Segal was hired to create a stable landscaping plan for the site.

50

51 Segal said that the original landscaping plan was created without any testing of the site soils. After
52 core samples were taken, an updated plan needed to be developed because of the shallow soil and
53 the existence of bedrock in certain areas. Segal reviewed his proposed plan that would contain
54 species of plants that would survive on the existing site.

55

56 Fournier asked for clarification of why this change needs to be brought back to the Planning Board
57 for review.

58

59 Baker stated that the original landscaping plan was part of an approved special permit and that one
60 of the conditions of the resolution was approval of the landscaping plan by the Village Code
61 Officer and Village Engineer. A change in the plan, therefore, requires Planning Board approval of
62 the new plan but does not require a new special permit.

63

64 Scott agreed.

65

66 Segal reviewed his reasoning for using the proposed plants.

67

68 The Tree Law has no impact on this project.

69

70 Schleelein asked about erosion and the transfer of water to other properties. Segal answered that
71 the site is very stable and water runoff has been to a minimum and most of the clearing of the site
72 contained the removal of Buckthorn.

73

74 Gillespie moved to accept the new as-built landscaping plan. Seconded by Capogrossi.
